**Update**

The motion for certification of this action as a class proceeding is scheduled to proceed on August 22 - 25, 2011 before Justice Strathy, at the Court House, 361 University Avenue, Toronto, Ontario. At the same time, two of the Defendants are seeking to have parts of the case dismissed by way of Summary Judgment. We have prepared and filed our motion records and have received the responding motion records of the Defendants.

In advance of the motion, numerous affidavits and cross-examinations have been conducted and lengthy facta (written legal arguments for the judge) have been prepared.

Class members are encouraged and welcome to attend in Court, although you would only be observing the case and not speaking in Court. However, the presence of class members would be of importance in demonstrating your interest in the case, and its importance to you.
